

## FY2023 Budget Season Toolkit (as of March 14, 2022)

#### Situational Analysis

The COVID-19 pandemic continues to impact the lives of children and families across the District. Mayor Bowser and the DC Council have been very responsive to meeting the community's urgent needs by quickly allocating federal funds throughout the crisis. Their steps to keep doors open and help the community rebuild as the city recovers are very much appreciated. However, as this year's budget season begins, Under 3 DC will continue to push them to respond to the urgent needs of the early learning community by deepening investments in programs that have kept families healthy during these challenging times. We will also ask them to ensure that fair compensation reaches our teachers.

During agency performance oversight hearings that took place over the last six weeks, Under 3 DC Coalition members and partners testified to bring attention to the progress of programs funded in this year's operating budget. We also laid the groundwork for our coalition's FY2023 Birth-to-Three program budget requests.

Once Mayor Bowser releases her FY2023 budget this month, we will review her funding support for Birth-to-Three programs. Our coalition asks this year, while very important, are not major. However, if necessary, we will shift our gears to focus on convincing the DC Council to step in and fund programs that received insufficient support.

Throughout the entirety of the budget season, Under 3 DC will highlight our community's work on earned and owned media (Twitter and FB). Our goal is to remind Mayor Bowser, her administration, Chairman Mendelson, and the DC Council just how vital the District's early care and education community is to the wellbeing of our city's families and the economy.


